

In July, the IIJ, with support from the Governments of the United States and the United Kingdom, launched publicly – during a high-level event – the much anticipated [IIJ Criminal Justice Practitioner's Guide for Addressing Racially or Ethnically Motivated Violent Extremism \(REMVE\)](#). This timely new Practitioner's Guide gives policymakers and practitioners a better understanding of the tools at their disposal to counter the REMVE threat. It builds on existing tools and approaches, including good practices developed by the GCTF, and outlines where new strategies and authorities are needed. Importantly, the Guide equips practitioners with a clear set of good practices for how to address REMVE effectively and in compliance with human rights and the rule of law. ## First of its Kind Training Curriculum: Multi-Actor P/CVE Intervention Mechanisms

In June, the IJ with support from the European Union, launched a first-of-its-kind training curriculum to support the design and implementation of multi-actor intervention programmes for preventing and countering violent extremism (P/CVE). The curriculum equips decision-makers and practitioners with the necessary knowledge and skills to set up multi-actor P/CVE intervention programmes. The curriculum draws on recommendations, guidance and good practices developed by the United Nations, GCTF, OSCE, and other multilateral bodies, and was further informed by two sets of expert consultations and pilot training workshops in Kenya and North Macedonia.

## Donor & Partner News

In addition to continued support from our steadfast donors and partners, we recently received two new exciting grants. The first is from the Federal Foreign Office of the Government of Germany, with a focus on Designated Non-Financial Businesses and Professions (DNFBP) and Counter-Terrorism Financing. Under this grant, the IJ will deliver an innovative workshop in the Ivory Coast in October to enhance the skills and knowledge of regulators, criminal justice and relevant private sector practitioners from 11 countries in West Africa, in tackling the use of DNFBPs for terrorist financing.

The second grant, from the Government of Australia's Department of Foreign Affairs and Trade (DFAT), will support the delivery of two foundational skills courses under the online Counter-Terrorism Academic Curriculum (eCTAC) and the Counter-Terrorism Academic Curriculum (CTAC). The Australian-funded courses will focus on building the capacity of investigators, prosecutors and examining judges from, and operating in, Southeast Asia, and will be implemented in the course of the coming

year.

## **IJ Advisory Board Meeting**

The IJ Advisory Board met online in June and received updates on the Institute's progress and upcoming projects, the recommendations from the recent Governing Board of Administrators (GBA)-commissioned Strategic Review, and other areas of focus. In April, the IJ convened an initial expert meeting as part of an exciting project to develop a specialised counter-terrorism capacity building and train-the-trainer programme on Risk Assessment of Violent Extremist and Terrorist Offenders. This timely curriculum for prison officials focused on how risk and needs assessment can be instrumental in managing a prison's population of violent extremist and terrorist offenders. This includes classification and categorisation, understanding the risks they may pose towards prison staff, assessing and evaluating individual inmates, and as part of tailored rehabilitation and reintegration programmes.

## **IJ Investigations Initiative: Multi-Agency 'Intelligence-led, Evidence-driven' Counter-Terrorism Investigation Capacity-Building in Somaliland - Debriefing Phase**

**6 – 8 July 2021, Somaliland**

During this two-day debriefing workshop, senior leaders from seven different Somaliland agencies met to discuss the implementation of the recommendations identified in the previous phase of the project. Practitioners who had participated in the training discussed the impact that this innovative curriculum had had in their daily work. This included developing international judicial cooperation, improved parallel collection of evidence and intelligence, application of the law for practitioners, a more systemic approach to managing risk, enhanced crime scene management, more effective investigation processes, and building rapport during interviews.

## IJ Juvenile Justice Initiative: First Niger Online Workshop on Justice for Children in Terrorism Cases

27 – 29 July 2021, Online Workshop

In July, the IJ convened its first national-level workshop for Niger, at their request, under the auspices of the IJ Juvenile Justice Initiative. The workshop outlined the need to support juveniles when conducting an age assessment; Nigerien law provides that children under the age of thirteen are not criminally responsible and most children presented to the public prosecutor do not possess identification documents. To address this challenge, the practitioners determined that the initial investigation must involve social workers and health care workers, and investigators must attempt to locate family members and involve community leaders to determine the age of the child.
